- Items must be of original, unique work or design. The RFM will not allow any items made from commercial kits of any kind.
- The starting material must be significantly altered and enhanced by the artist.
- The product must meet basic expectations of product life, function and safety.
- Clothing sold at Market must be made by the artist.
- Items commonly associated with venues such as flea markets or county fairs will not be accepted.

RENTAL OF SPACE: Prospective vendors are required to submit a completed application for approval. Payment must be made prior to the first Saturday they wish to sell at the Market. Space assignments are issued by the Market Manager.
