- Items must be original works of art created by the seller or family member. The hand-created component must dominate the commercial component, and the commercial component must be transformed in a way that makes the work unique.
- Items must be of original, unique work or design. The RFM will not allow any items made from commercial kits of any kind.
- The starting material must be significantly altered from its original state and enhanced by the artist.
- The product must meet basic expectations of product life, function and safety.
- Clothing sold at Market must be made by the artist.
