- Items must be original works of art created by the seller or family member. The hand-created component must dominate the commercial component, and the commercial component must be transformed in a way that makes the work unique.
- Items must be of original, unique work or design. The RFM will not allow any items made from commercial kits of any kind.
- The starting material must be significantly altered from its original state and enhanced by the artist.
- The product must meet basic expectations of product life, function and safety.
- Clothing sold at Market must be made by the artist.

RENTAL OF SPACE: Prospective vendors are required to submit a completed application at least one week prior to the first Saturday they wish to sell at the Market. Payment for space should be submitted prior to the first sale date. Space assignments are issued by the Market Manager.
